Project Rationale and Linkage to Country/Regional Strategy	The government's Eleventh Five Year Plan, 2007/2012, outlines the government's development strategy that includes the reduction in interstate disparities. It seeks to redress interstate divides in economic and social indicators by proposing various instruments (including fiscal incentives for lagging regions, industrial policies, and directly targeted programs) to achieve this objective. ADB has long experience in assisting the lagging states. Since 2003, ADB had initiated operations in Assam, Bihar, Chhattisgarh, Jammu and Kashmir, Orissa, and Uttarakhand. While ADB has responded to the government's evolving needs, the challenges of designing and implementing operations in the states with weak capacity and little familiarity with ADB are enormous. ADB's experience since 2003 has shown that it takes much longer than initially anticipated to design and implement investment projects in those states. Building up good communication channels with officials of new state governments and executing agencies, and familiarizing them with ADB policies and procedures, takes time. Despite these challenges, ADB remains committed to engaging with states with weak capacity. Adequate staff and TA resources need to be provided for capacity building during processing and implementation

Progress Toward Outcome	Under the TA, a Project Support Office (PSO) was set up in Guwahati (Assam) during November 2010 to December 2013, from where a team of 3 national consultants i.e. team leader-cum-institutional development specialist, project management specialist and procurement specialist provided capacity building support to EAs of ADB-financed projects in 6 weak capacity states i.e. Assam, Sikkim, Meghalaya, Tripura, Nagaland and Mizoram in north eastern region of India. The PSO was closed in December 2013. Later, the TA closing date was extended twice up to 28 February 2017. 5 more individual consultants were recruited for providing implementation support to EAs in North Eastern region.

Status of Implementation Progress (Outputs, Activities, and Issues)	Under the TA, a Project Support Office (PSO) was set up in Guwahati (Assam) during November 2010 to December 2013, from where a team of 3 national consultants i.e. team leader-cum-institutional development specialist, project management specialist and procurement specialist provided capacity building support to EAs of ADB-financed projects in 6 weak capacity states i.e. Assam, Sikkim, Meghalaya, Tripura, Nagaland and Mizoram in north eastern region of India. In December 2012, ADB approved a minor change in implementation arrangement to increase the TA amount by \$450,000 and extended the TA closing date to 28 February 2015. The PSO was closed in December 2013. In January 2015, INRM approved another extension of TA closing date by 2 years, up to February 2017 and undertook a minor change by increasing the person-months inputs for the Project Management and Procurement Specialist to meet the demand of EAs for hand holding support in these areas. Overall, eight individual Consultants were engaged for providing hand holding support for project implementation and enhancing readiness for processing of new projects for ADB projects in North East, primarily focusing on loans in the Urban and Transport sectors.
